1. To set up an Employee Account with Experian Verify:

2. "Create Account" and enter the following information:

a. Employer Access Code: 6D964A49

b. **SSN/SIN/ID**: Enter your Employee ID (EEID). If you don't know your Employee ID, you can look it up in Workday. If you don't have access to Workday, you can reach out to the Sutter Health Employee Line at 1-916-297-8300 or 1-855-398-1631 to obtain this information.

- c. First Name
- d. Last Name
- e. DOB: Enter your date of birth in mm/dd/yyyy format
- f. Email Address: Enter your Work Email Address (preferred) or Personal Email Address
- 3. Click on the checkbox "I agree to the terms of use."
- 4. Click Create an Employee Account. Note: A password setup link will be sent to your email address. Click the link the create a password and activate your account.
- 5. Login with your credentials.

Once logged in:

- 1. Select "PSLF Letter"
- 2. A letter with submittal instructions and completed ECF will be generated

PLEASE NOTE: Experian's PSLF fulfillment team does **not** submit your application, communicate with MOHELA/Fed Loans, or have any additional insight to your application status. **Any questions regarding your status will need to be directed to MOHELA/Fed Loans.** Updated information regarding submittal can be found at <u>studentaid.gov</u>.
